

INCREASE IN TUITION FEE*

We advise that tuition fees will increase on 01 January 2010.

However, if you pay the initial fees for the course that are set out in the letter of offer by 31 December 2009 then the increase in tuition fee will only take effect on 28 April 2010 (instead of 01 January 2010) and, you will then also be able to “lock in” the current fee for your course[#] by paying the balance of the course fee by 27 April 2010.

Alternatively, you can also “lock in” the current fee for the course by paying the full course fee in advance by 31 December 2009.

If you do not make payment of the initial fees or full course fee set out in the letter of offer by 31 December 2009 then you will be required to pay the new tuition fees (effective 01 January 2010) that is applicable to your course and to the relevant campus.

**This notice is for the information of prospective students who have been or are issued with a letter of offer on or before 31 December 2009 and have not paid the fees set out in the letter of offer.*

[#]The increase in tuition fee will still be applicable for any extension of studies in the course or any new courses.

Frequently Asked Questions

Q.1 What are the new tuition fees?

A.1 The new tuition fees payable depend on the course (Business or IT), visa category and the campus. Please contact Student Services for additional information.

Q.2 Can I lock in my current fees for my course?

A.2 Prospective students can “lock in” the fees for their course (as set out in the letter of offer) by making full payment of the course fee in advance before 31 December 2009 or by making the following 2 payment:

- 1) pay the initial fees set out in the letter of offer by 31 December 2009; and
- 2) pay the balance of the course fee by 27 April 2010.

Q.3 What happens if I do not pay any fees by 31 December 2009?

A.3 You will be required to pay the new (increased) tuition fee applicable to your course and to the relevant campus.
