"College" means Australian Pacific College, English Unlimited and Australian Pacific Travel and Tourism.

"ESOS Act" means the Education Services for Overseas Students Act 2000.

"EU" means English Unlimited.

"LOO" means Letter of Offer.

"Overseas Student" means a person (whether within or outside Australia) who holds a student visa as defined by the ESOS Act.

"Policy" means this Payment and Assurance of Fees Policy.

"RTO" means a registered training organisation.

"TPS" means the Tuition Protection Service.

1. PAYMENT OF FEES

- 1.1 Upon receipt of an executed LOO and all relevant fees, the College will send a successful applicant a CoE. The CoE is required for the Overseas Student to apply for a student visa.
- 1.2 Payment of fees must be in Australian dollars and all bank fees paid by the applicant. This includes foreign exchange conversion fees applied by the overseas and Australian bank if it is an overseas telegraphic transfer.

- 1.8 All money due to the College will be deemed to have been paid only when all the funds have been cleared and transferred to the College from the financial institution and/or College representative (agent) and a receipt issued by the College.

2 ASSURANCE OF FEES (OVERSEAS STUDENTS)

- 2.1 Under the ESOS Act, the College pays an annual Tuition Protection Levy to the TPS. The TPS is an initiative of the Australian Government to protect the tuition fees of international students studying in Australia on a student visa.
- 2.2 In the unlikely case of the College being unable to fully deliver the applicant's course of study, the TPS ensures that international students are able to either:
